Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data gathering, analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information analysis, and dissemination dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.1 Actions to (a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote conserve energy or

energy efficiency that would not have the potential to cause significant changes in the indoor or outdoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, manufacturers, and designers), water organizations (such as utilities), and governments (such as state, local, and tribal). Covered actions include, but are not limited to weatherization (such as insulation and replacing windows and doors); programmed lowering of thermostat settings; placement of timers on hot water heaters; installation or replacement of energy efficient lighting, low-flow plumbing fixtures (such as faucets, toilets, and showerheads), heating, ventilation, and air conditioning systems, and appliances; installation of drip-irrigation systems; improvements in generator efficiency and appliance efficiency ratings; efficiency improvements for vehicles and transportation (such as fleet changeout); power storage (such as flywheels and batteries, generally less than 10 megawatt equivalent); transportation management systems (such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition); development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to Marin Clean Energy (MCE) to install battery energy storage systems (BESS) at critical facilities across the service area. It is anticipated that with award activities, MCE would equip at least four non-profit facilities with an anticipated average battery size of 250-kilowatt hours, which would be paired with already existing, or planned, solar photovoltaic (PV) systems. If a chosen facility does not have an existing PV system, the installation of a PV system would not be funded by this award.

The proposed project would be comprised of three Phases. Award activities in Phase One (P1), "Engagement and Agreements," would include MCE developing project proposals and outreach planning, engaging with potential participants, determining project locations, and securing agreements once project sites are identified.

Proposed award activities in P2, "Installation and Commissioning of Storage Systems," would include acquiring permits, installing BESS at sites identified in phase one, and acquiring permission and approval letters from Pacific Gas and Electric to operate at the project sites.

Additional award activities in P3, "Monitoring and Reporting," would include monitoring the effectiveness of the installed BESS, particularly during peak hours, and evaluating their impact on reducing grid demand.

As award activities completed during P1 would identify project locations for P2 and P3, there is insufficient information available at this time to complete a thorough review of anticipated award activities identified in P2 and P3. This NEPA determination applies only to P1; P2 and P3 will be reviewed once the necessary details are submitted to DOE for additional impacts analysis and further NEPA review.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources due to P1.
