Rationale for determination:

The U.S. Department of Energy (DOE) Office of Energy Efficiency and Renewable Energy (EERE) Water Power Technologies Office (WPTO) is proposing to issue a Funding Opportunity Announcement (FOA) (DE-FOA-0003323) for advancing the commercialization and adoption of water power systems and solutions through incubation and acceleration programming and services that support entrepreneurs and small businesses in marine energy and/or hydropower. The FOA includes one Topic Area: Water Power Incubation and Acceleration.

All selected awards would be limited to activities of an intellectual, academic, or analytical nature. All work would occur in the United States. Anticipated award activities would include but are not limited to business development support and training, private sector fundraising readiness, public funding education and workshops (e.g., Small Business Innovation Research/Small Business Technology Transfer [SBIR/STTR] workshops), end-user engagement and partnerships to advance water power solutions, and fostering connections between entrepreneurs, technology developers, academic institutions, and state, local, and tribal entities towards building a water power innovation ecosystem. DOE does not anticipate any impacts to resources of concern.

Participating entities would be identified as part of the award selection process. As such, award recipients and locations are not yet known. However, further NEPA review would not be required for activities of selected awards under this FOA provided that all activities are consistent with the activity descriptions in this NEPA Determination.

NEPA PROVISION

DOE has made a final NEPA determination.

Include the following condition in the financial assistance agreement:

This NEPA Determination applies to the issuance of the FOA as well as all awards selected under the FOA, provided the scope of the selected awards remains consistent with the intent of the FOA, as issued. If selected applicants propose to use project funds for activities outside the scope of this NEPA Determination, additional NEPA review would be required.
