Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Siting, construction, modification, operation, and decommissioning of facilities for indoor small-scale research and development projects and small-scale pilot projects using nanoscale materials in accordance with applicable requirements (such as engineering, worker safety, procedural, and administrative regulations) necessary to ensure the containment of any hazardous materials. Construction and modification activities would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible).

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to The Regents of the University of California, Irvine, to design, develop, fabricate, and test highly durable and manufacturable fuel cell membrane electrode assemblies (MEAs) with low-platinum group metal (PGM) novel cathode catalyst loading.

Award activities would be conducted at the Interdisciplinary Science and Engineering Building (ISEB) at the University of California, Irvine; Irvine Materials Research Institute (IMRI); National Fuel Cell Research Center (NFCRC) in Irvine, CA; Bosch RTC in Sunnyvale, CA and Watertown, WA; Cabot Corporation in Billerica, MA; Drexel University in Philadelphia, PA; and IRD Fuels in Albuquerque, NM.

The proposal would be spread over three budget periods (BP) including 8 tasks per BP. Task activities include material discovery and innovation synthesis, durable catalyst supports, modified catalyst-ionomer interfaces, advanced catalyst characterization, advanced component integration, electrode component distribution and morphology design, MEA diagnostics for accelerated testing, a research and development community benefits plan, and feasibility studies for high volume and high throughput MEA manufacturing. Tasks repeat in each BP.

Award activities would occur entirely within existing research and development facilities that are purpose-built for the type and scale of activities being proposed. No change in the use, mission, or operation of existing facilities would arise out of this effort.

Award activities would involve handling and use of various hazardous materials and nanoscale materials, including metal nanoparticles, carbonaceous particles, organic solvents, and acids. Project activities involving hazardous materials pose no risk to the public. Hazardous materials would be utilized, managed, stored, and disposed of in accordance with applicable federal, state, and local environmental regulations. Existing lab, and governmental health and safety policies and procedures would be followed, including employee training, proper protective equipment,

engineering controls, monitoring, and internal assessments.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
