AMENDED NEPA DETERMINATION: (See attached original Determination, dated March 28, 2019)

This Amended Determination follows the approval of additional funds and milestones to support the project team's small-scale, research and development activities to develop an optimal way to connect offshore floating wind turbines to a high-voltage direct-current transmission network. Specifically, the project team will use the additional funds to (1) evaluate different topologies suitable for connecting the proposed architecture to a high-voltage direct current (HVDC) transmission network; (2) compare and down-select most suitable topology based on various performance matrices; and (3) complete a kW-scale design and test to evaluate HVDC interconnection. If successful, the project team will enable deeper penetration of wind energy harvesting systems further into oceans (up to 230 miles from the coastline) to unlock several petawatt-hours of energy.

Project activities will be conducted at an existing facility at the University of Illinois at Urbana-Champaign (Urbana, IL). Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal. State, and local regulatory requirements.

<u>Proposed Action Title</u>: University of Illinois at Urbana-Champaign -- Megawatt-scale Power-Electronic-Integrated Generator with Controlled DC Output

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to create an efficient, reliable, and compact wind energy conversion system by integrating a multi-port permanent-magnet synchronous generator (PMSG). Specifically, the project team will (1) establish specifications for a megawatt (MW)-scale wind energy conversion system and conduct simulation study; (2) develop generator and power converter models; (3) develop in-lab kilowatt (kW)-level hardware to validate electromagnetic, thermal, and mechanical design; and (4) optimize generator-converter co-design and complete performance/cost analyses. If successful, the technology will allow deeper penetration of wind energy harvesting systems into untapped areas of the ocean exclusive economic zones, which extend up to 230 miles from the coastline.

Project activities will be conducted at an existing facility at University of Illinois at Urbana-Champaign (Urbana-Champaign, IL) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.
