The Nevada Environmental Program Services (EPS) contract is a Cost-Plus-Award-Fee (CPAF) contract as defined by the Federal Acquisition Regulation (FAR). Fee is available to the Contractor for the completion of implicit performance in areas of business relations, management of key personnel/subcontracts, cost control, schedule, quality of product or service, health and safety and explicit completion of deliverables or milestones. Fee is earned based on an annual evaluation of the Contractor's performance after issuance of the Award Fee Determination (AFD). Total available fee for each contract year is identified in Section B, *Services and Prices/Costs*, of the contract. This fee scorecard highlights the award fee earned by the Contractor for the evaluation period: October 1, 2016 – September 30, 2017.

Available fee for the EPS contract is comprised of two components: Award fee (40%) and performance-based incentive fee (60%). Award fee is comprised of subjective evaluation measures focusing on implicit performance in areas of business relations, management of key personnel/subcontracts, cost control, schedule, quality of product or service, and health and safety as identified in the Performance-Based Award Fee Plan, contract section J, Attachment J-G, Part I. The total available subjective award fee for this period was \$351,037.

The objective incentive fee measures consist of explicit deliverables or milestones the Contractor must complete to earn fee as identified in the Performance-Based Incentive Fee Plan, contract section J, Attachment J-G, Part II. The total available objective award fee for this period was \$506,000.

Notable Achievements:

Navarro made a concerted effort to contribute and participate in transfer activities required for the transition of the EM Nevada Program work to the EM Consolidated Business Center (EMCBC) including leading the development of a partnering agreement between the EM Nevada Program, the EMCBC, and Navarro.

Navarro was successful in maximizing the efficiency of current staff and mitigating the loss of critical resources.

Navarro achieved cost and schedule performance indices, both within ±5% of planned work scope values.

Navarro, working with the management and operating contractor, completed the environmental corrective actions at CAU 568: Area 3 Plutonium Dispersion Sites and CAU 573: Alpha Contaminated Sites. These corrective actions included the removal of more than 18,000 cubic feet of low-level waste and 22 cubic feet of mixed-LLW.

Navarro continues to demonstrate outstanding safety, health, and radiological performance. Under Navarro's diligent leadership, there have not been any lost work day cases under the contract.
