

Proposed Action Title: Install TV Monitors at SRTE Entry Control Facilities 701-3H and 701-44H

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Modification Traveler MT-TRI-2024-00006 will install two TV monitors at the Entry Control Facilities.

Visitors that approach the SRTE Entry Control Facilities (ECFs) may not be aware that an emergency preparedness drill or a real site emergency is occurring. Emergency preparedness announcements from SRTE Operations are periodically transmitted aurally through the SRTE public address system during an event. It is desired to supplement these messages by displaying constant video messages while the drill or real site emergency is in progress through the use of TV monitors to be installed at Entry Control Facilities 701-3H and 701-44H.

The installation of TV monitors capable of displaying visual messages from SRTE Operations will supplement the required SRTE audio announcements from the public address system; thereby enhancing personnel safety of visitors as they approach points of access to SRTE.
