

Proposed Action Title: Installation of a New Pyroprocessing Inert Glovebox in Building 786-A

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The proposed modification will support Weapons Production Technology (WPT) group to install a new pyroprocessing inert glovebox in Building 786-A, Engineering Development Laboratory (EDL).

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
