Proposed Action Title: Georgia Institute of Technology -- Risk-Aware Market Clearing for Power Systems

Proposed Action Description:

Funding will support the project team's information gathering and analysis efforts to at provide a blueprint for an end-to-end, data-driven approach to Risk-Aware Market Clearing (RAMC), where risk is explicitly modeled, quantified, and optimized, striking a tradeoff between cost and system-level risk minimization. Specifically, the project team will (1) make renewable intermittent resources dispatchable, possibly in combination with other assets through fundamental innovations in machine learning, sampling, and optimization; and (2) use data, forecasts, operator interventions, and outages to conduct data analysis, modeling, and simulations. If successful, the project will enable a new generation of tools necessary to help system (wind and solar) operators quantify and characterize system-level risk.

The proposed project activities under this award are limited exclusively to intellectual, academic, or analytical activities. The project team will not conduct physical experiments, prototype fabrication, demonstration projects, or similar activities under this award.
