

Proposed Action Title: HE-DV 30/3-30/6 Underground Fiber

Program or Field Office: NDMO

Location(s) (City/County/State): Morton, North Dakota

Proposed Action Description:

Extension of underground work originally submitted in 2018 for 30/5 to 30/6 to be expanded all the way to 30/3. Project includes installation of underground fiber lines.

• WAPA determined that the proposed project would not cause significant changes to risks to bio/natural resources, and would therefore reach a no effect determination.

• WAPA determined no potential to affect cultural resources or Historic Properties affected for the Proposed Action. If, during the course of any ground disturbance related to the project, any bones, artifacts, foundations, or other indications of past human occupation of the area are uncovered, the project will be stopped, and the State Historic Preservation Officer notified immediately.

• Desktop qualitative review of impacts to transportation, air quality, hazardous materials, human health and safety, socioeconomic & community resources. No concerns identified.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
