## VENTURE GLOBAL PLAQUEMINES LNG, LLC DOCKET NO. 24-33-LNG

**PROPOSED ACTION DESCRIPTION:** Venture Global Plaquemines LNG, LLC (Plaquemines LNG) filed an application (Application) with the Department of Energy's (DOE) Office of Fossil Energy and Carbon Management (FECM) on April 22, 2024. Plaquemines LNG supplemented its Application on May 1, 2024. In its Application, as supplemented, Plaquemines LNG seeks blanket authorization to engage in short-term exports of liquefied natural gas (LNG) previously imported into the United States from foreign sources. Plaquemines LNG requests authorization to export this LNG in a volume equivalent to 6 billion cubic feet (Bcf) of natural gas on a cumulative basis for a two-year period commencing on the earlier of July 22, 2024, or the date of an order granting the requested authorization. The Application was submitted pursuant to section 3 of the Natural Gas Act (NGA).¹ and 10 CFR Part 590 of DOE's regulations, and states that the proposed exports qualify as "small-scale natural gas exports" under DOE's regulations at 10 CFR 590.102(p) and 590.208(a).

As relevant here, Plaquemines LNG seeks to export the previously imported LNG by vessel from the Plaquemines LNG Terminal (Terminal), currently under construction in Plaquemines Parish, Louisiana, to any country with which the United States does not have a free trade agreement (FTA) requiring national treatment for trade in natural gas, and with which trade is not prohibited by U.S. law or policy (non-FTA countries). <sup>2</sup>

DOE's proposed action is to authorize the exports described in the Application, as supplemented, as small-scale natural gas exports. If granted, the authorization would permit the requested exports of previously imported LNG by vessel on a short-term basis from the Terminal, subject to certain terms and conditions set forth in the DOE order.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
