Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Plug Power Inc. to establish a manufacturing process of proton exchange membrane electrolyzers at the multi-gigawatt scale. These activities would develop improved formulation processes, automate electrolyzer stack manufacturing and assembly, and improve the testing process. Manufacturing and automation would occur at Plug Power Inc. in West Henrietta, New York. Research and development support and laboratory testing would occur at Plug Power Concord in Concord, New York, National Renewable Energy Laboratory in Golden Colorado, and the University of Connecticut in Storrs, Connecticut.

Potential hazards include use of manufacturing equipment related to electrolysis stack production. No materials not already involved in the development of electrolysis stacks would be introduced. Existing health, safety, and environmental policies and procedures would be followed at all facilities, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments.

All project activities would be completed in existing, purpose-built laboratory facilities. A new electrolyzer stack test stand would be installed on an existing, exterior concrete pad at Plug Power in West Henrietta. No ground disturbance would occur at any facilities. No facility modifications, new permits, or licenses would be required. DOE does not anticipate any impacts to resources of concern due to the proposed project activities.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.
