Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

#### Description:

**B5.1** (a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote energy Actions to efficiency that would not have the potential to cause significant changes in the indoor or outdoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such conserve as builders, owners, consultants, manufacturers, and designers), organizations (such as utilities), and energy or water governments (such as state, local, and tribal). Covered actions include, but are not limited to weatherization (such as insulation and replacing windows and doors); programmed lowering of thermostat settings; placement of timers on hot water heaters; installation or replacement of energy efficient lighting, low-flow plumbing fixtures (such as faucets, toilets, and showerheads), heating, ventilation, and air conditioning systems, and appliances; installation of drip-irrigation systems; improvements in generator efficiency and appliance efficiency ratings; efficiency improvements for vehicles and transportation (such as fleet changeout); power storage (such as flywheels and batteries, generally less than 10 megawatt equivalent); transportation management systems (such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition); development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

#### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to the Gorham Randolph Shelburne Cooperative School District (District) to replace five low-efficiency oil boilers with energy-efficient oil boilers and burners at the Gorham Middle High School (Gorham, NH). The project location is owned and operated by the District. A previous proposal from the District included resealing the roof and installing a solar photovoltaic array at the Edward Fenn Elementary School. A NEPA determination (ND) was made on 10 January, 2024 and since that time, the District has modified their objectives. This ND applies to this award as modified.

Project activities would include removing the existing boilers and replacing them with five new modulating oil boilers. Additional activities would include installation of new burners, mixing valves, circulator pumps, associated piping, and controls.

There would be no ground disturbance associated with the proposed project; award activities would occur in the existing boiler room. No change in the use, mission, or operation of existing facilities would arise out of this effort. All required permits, including a local building permit from the Town of Gorham, would be obtained prior to construction activities.

Project activities would involve typical hazards associated with construction, as well as mechanical and electrical work. Proper safety and environmental policies and procedures, including the use of personal protective equipment, would be implemented on-site. All activities would comply with existing federal, state, and local laws and regulations.

STATE: NH

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
