Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Princeton University to develop and test the viability of a low-cost alkali-activated cement and a calcined low-grade kaolin clay with existing technology. Material synthesis, testing, characterization, and analysis would occur at Princeton University in Princeton, New Jersey. Material integration, characterization, and data dissemination would occur at Cornell University in Ithica, New York. Material synthesis, characterization, analysis, and public engagement would occur at University of Texas at Austin, in Austin, Texas. Pre-demonstration trials would occur at Ash Grove Cement in Sylacauga, Alabama. Trial batch placement would occur at Ash Grove Cement in Omaha, Nebraska.

All project activities would be completed in existing, purpose-built laboratory facilities. No facility modifications, new permits, or licenses would be needed to perform project activities. Potential hazards include the use and handling of various chemicals, micro-sized powders, and x-ray generating devices. Existing university health, safety, and environmental policies and procedures would be followed at all facilities, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
