Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer funding to CertainTeed, LLC (CT) to install solar collecting parabolic mirrors and an expansion tank to collect solar energy at CT's manufacturing plant and reduce carbon emissions.

Award activities would be carried out at CT's industrial manufacturing facility (Shakopee, MN) and would include the construction and field installation of ten solar collecting parabolic mirrors. Engineering design, measurement, and verification services would be carried out by Lawrence Berkeley National Laboratory (Berkeley, CA). Existing university relations in the community would be included in order to plan a community learning day at the site.

Ten solar collecting parabolic mirrors would be installed outside adjacent to CT's existing building, in a containment area of approximately 100x200 feet (ft.). Some ground disturbance would be necessary to clear, excavate, and lay the necessary foundations and pavement. A perimeter of an additional 20 ft. of additional temporary ground disturbance would be needed during construction. The concrete base for the system would have a concrete base of 11x11x1.5 ft. The expansion tank would have a volume of approximately 200 gallons. No tree cutting or ground clearing would be necessary to carry out the award activities.

Individuals working on this project could be exposed to physical hazards due to construction, the usage of industrial equipment, hand tools, and power tools. Existing corporate health and safety policies and procedures would be followed including employee training, proper protective equipment, engineering controls, and monitoring. Additional policies and procedures would be implemented as necessary if new health and safety risks are identified.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.
