Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:	
A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Rationale for determination:	
The U.S. Departmen	t of Energy (DOE) is proposing to provide funding to the University of Central Florida (UCF) to

design, fabricate, and test a solar-powered thermochemical energy storage system. A 5-kilowatt (kW) solar receiver/chemical reactor would be designed, fabricated, and tested at UCF in Orlando, Florida. A chemical reduction reactor would be designed, fabricated, and tested at RedoxBlox Inc. in San Diego, California. A chemical oxidation reactor-heat exchanger would be designed, fabricated, and tested at Oregon State University in Corvallis, Oregon. Computational modeling and fabrication of small materials samples would occur at the University of Houston in Houston, Texas. Finally, a 5-kW solar receiver/chemical reactor would be tested at the Sandia National Laboratories in Albuquerque, New Mexico.

All project activities would be completed in existing, purpose-built facilities. While award activities would involve the fabrication and installation of equipment and components, there would be no modifications to or change in use of existing facilities. No new permits or licenses would be needed to perform award activities. Award activities would involve typical hazards associated with engineering laboratories, such as use and handling of electrical components, equipment, and machinery. Award recipients would adhere to established health and safety policies and procedures when performing project work, and would observe all applicable federal, state, and local health, safety, and environmental regulations.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

#### FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
