Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

Covered actions include, but are not limited to weatherization (such as insulation and replacing windows and doors); programmed lowering of thermostat settings; placement of timers on hot water heaters; installation or replacement of energy efficient lighting, low-flow plumbing fixtures (such as faucets, toilets, and showerheads), heating, ventilation, and air conditioning systems, and appliances; installation of drip-irrigation systems; improvements in generator efficiency and appliance efficiency ratings; efficiency improvements for vehicles and transportation (such as fleet changeout); power storage (such as flywheels and batteries, generally less than 10 megawatt equivalent); transportation management systems (such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition); development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to the City of Racine (City), WI to develop, design, and install a solar photovoltaic (PV) carport system at the City's Bus Garage, incorporate energy efficiency upgrades, including advanced building control systems and installing light emitting diodes (LED) at multiple locations, and conduct existing building commissioning (EBCx), and implement building performance design solutions at multiple locations. All project locations are owned by the City.

Project activities at each location would be as follows:

The City Hall Annex and the Safety Building would include LED upgrades; an EBCx audit and implementation of identified energy saving measures would be performed at City Hall, Cesar Chavez Community Center, Dr. John Bryant Community Center, Tyler Domer Community Center, Humble Park Community Center, the Public Library, and the Safety Building; the Bus Garage would include design and installation of 270-kilowatt solar PV array in the parking lot.

The proposed project would be comprised of six Tasks. This NEPA Determination (ND) only applies to Tasks 1 and 2. Task 1 would include reviewing and analyzing existing utility data at project locations, EBCx analysis, identifying LED lighting upgrade locations, finalizing the design of the solar PV array and LED upgrades, obtaining necessary permits and utility agreements, and determining construction schedule. Task 2 would include equipment and material procurement and storage.

Tasks 3, 4, 5, and 6 would include installation of a PV solar array at the Bus Garage, installation and retrofit of LEDs at the City Hall Annex and Safety Building, installation and implementation of the identified EBCx energy conservation measures, and project commissioning. Certain award activities in Tasks 3-6 would require consultation under Section 106 of the National Historic Preservation Act of 1966, as amended. Additionally, award activities completed during Tasks 1 and 2 would further identify project activities that would be completed in Tasks 3-6. Once the necessary details are submitted, DOE would complete additional NEPA review and Section 106 consultation prior to Tasks 3-6 being implemented.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources during implementation of Tasks 1 and 2.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
