Proposed Action Title: Synvitrobio, Inc. (d/b/a Tierra Biosciences) -- High-Throughput Cell-Free Protein Synthesis for Rapid Bioenergy Pathway Improvements

## Proposed Action Description:

Funding will support the project team's small-scale research and development activities to continue the development of its innovative high-throughput cell-free protein synthesis system. Specifically, the project team will complete (1) product blueprinting and process design, (2) scale the current platform using information gathered from customers, and (3) perform commercial feasibility assessment. If successful, the project team's on-demand protein production service will generate more than 500 unique proteins per week at scales appropriate for high throughput screening at a price point less than \$125 (reducing the cost of protein production by up to 250-fold). The team's production system will enable downstream screening operations critical to the establishment of a cell-free biomanufacturing industry that can disrupt traditional fermentative production of biofuels and related products and improve upon their carbon and energy efficiency.

Project activities will be conducted at an existing facility at Synvitrobio, Inc. (San Leandro, CA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.
