Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the Blackfeet Community College (BFCC) to install two roof mounted solar photovoltaic systems, totaling 148 kilowatts, on the BFCC campus.

Award activities would consist of grant management, design, engineering, developing an interconnection agreement, preparation, community engagement, installation, training, commissioning, interconnection, monitoring, verification of energy savings, and grant closeout.

Rooftop solar PVs would be installed on two facilities, the Kutoyis maintenance and storage facility, and the Land Grant Meat Processing Training Facility, both of which will be newly constructed at the time of PV installation. Construction of the two new facilities is funded outside of, and not part of this award. The project locations are on tribal trust land of Blackfeet Indian Reservation, and not eligible or listed on the National Register of Historic Places.

Minimal air emissions may result from the use of equipment during construction of the system. However, significant air impacts are not anticipated as emissions would be temporary and intermittent. Project activities would involve hazards associated with construction activities and working with electricity. Any risks working with hazards would be mitigated through established Tribal safety and construction protocols. The tribe would observe all applicable health, safety, and environmental regulations. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE found no effects would be expected as a result of the proposed project activities.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. The proposed action is categorically excluded from further NEPA review.
