Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

B3.6 Small-scale research and development, laboratory operations, and pilot projects Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to GE Packaged Power LLC, d/b/a GE Vernova Advanced Research Center (GEVAR) for the development of improved designs and manufacturing processes of gears used in wind turbine systems. Project activities would consist of research and development, laboratory operations, and data analysis.

Materials design and modeling, and manufacturing process modeling, would occur at GEVAR in Niskayuna, New York. Additional research, design, and characterization would occur at the Missouri University of Science and Technology in Rolla, Missouri, the University of Texas at Dallas in Richardson, Texas, and the Argonne National Laboratory in Lemont, Illinois.

All project activities would be completed in existing, purpose-built facilities. No facility modifications, new permits, or licenses would be needed to perform project activities. Potential hazards include the handling of metal powders and use of arc welding machines. Award recipients would adhere to established health and safety policies and procedures when performing project work, and would observe all applicable federal, state, and local health, safety, and environmental regulations.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.
