Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the City of Mandan to install a 75.9-kilowatt solar system to the rooftop of a Public Works Building located at 411 6th Avenue SW, Mandan, North Dakota. This project would be funded under the Administrative and Legal Requirements Document (ALRD) for the DOE's Energy Efficiency Conservation Block Grant (EECBG) Program Formula Infrastructure Investment and Jobs Act (EECBG Formula - IJJA).

Award activities would involve the installation of solar panels to the rooftop of a Public Works Building in Mandan, North Dakota. The 75.9-kilowatt solar system would include 138 bifacial modules, a ballasted racking system, a central string inverter, and surge protection. All solar panels would be mounted and installed as per the manufacturer's instructions, and all plans would be approved by electrical and structural engineers and abide by all associated laws. The roof of the building may need to be structurally reinforced; however, no substantial improvements are expected.

The City of Mandan would adhere to the terms and restrictions of the DOE executed Historic Preservation Programmatic Agreement with the State of North Dakota. The proposed activities would not result in any changes in use to existing facilities, ground disturbing activities, or potential health and safety hazards to the public or project workers. No air emissions are anticipated from the project, and any waste materials would be disposed of at the City of Mandan landfill unless disposal at a different location is required. Existing government and corporate health, safety, and environmental policies and procedures would be followed, including personnel training, proper personal protective equipment (PPE), monitoring, and internal assessments.

The City of Mandan would observe all applicable federal, state, and local health, safety, and environmental regulations and requirements. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

DOE has made a final NEPA determination.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
