Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

B5.16 Solar photovoltaic systems	The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the City of South Bend for installation of rooftop solar panels located at 1222 S Michigan Street, South Bend, Indiana. This project would be funded under the Administrative and Legal Requirements Document (ALRD) for the DOE's Energy Efficiency Conservation Block Grant (EECBG) Program Formula Infrastructure Investment and Jobs Act (EECBG Formula - IIJA).

Award activities would involve the installation of solar panels on the roof of the Central Fire Station building. Although project specs would be determined once a solar installer is selected, the solar array system would be no greater than 300 kilowatts. Installation would require the use of a crane, and the panels and racking system would be installed using hand drills. The racking system would be a mounting system, which would not compromise the roof warranty. Electrical work would be required to wire the panels and inverter(s) to the building. Coordination with the local utility company, Indiana Michigan Power, would occur to facilitate ties into the electrical grid. The Central Fire Station is currently in the process of replacing its roof. Roof replacement would occur regardless of the DOE award.

Proposed activities would not result in any operational changes to existing facilities, ground disturbance, or potential health and safety hazards to the public or project workers. Physical modifications would be required to install the rooftop solar array and connect it to the building's existing electrical system. A mitigation plan would be developed to ensure power for critical functions would not be interrupted during construction and installation of the solar array.

The City of South Bend must adhere to the terms and restrictions of the DOE executed Historic Preservation Programmatic Agreement (PA) with the State of Indiana State Historic Preservation Office (SHPO). The Central Fire Station was built in 2004. Under the PA, this project is exempt from further Section 106 consultation because the building is less than 45 years old.

Potential air emissions would be limited to vehicles and a crane to support the transport and installation of the solar panels. While the project site is located in a non-attainment air quality area, construction work would only last a few days and emissions would be temporary and intermittent. Waste generated onsite would include materials from the solar panel packaging and installation, such as cardboard, wiring, and plastic. Existing government and corporate health, safety, and environmental policies and procedures would be followed, including personnel training, proper personal protective equipment (PPE), monitoring, and internal assessments. The City of South Bend and their contractors would observe all applicable federal, state, and local health, safety, and environmental regulations and requirements, and would obtain and comply with all applicable permits. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

NEPA PROVISION

DOE has made a final NEPA determination.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
