

Proposed Action Title: Work in the 723-A High Pressure Laboratory

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC covers work that is done in the High Pressure Laboratory at 723-A. The High Pressure Laboratory pressure tests and leak tests components for customers across SRS and for other DOE Sites. Small scale fabrication and testing is also done in the 723-A High Pressure Laboratory. Any small scale testing work not covered by this EEC (and associated HAS) will have its own HAS and EEC. as necessary.
