

National Environmental Policy Act (NEPA) Determination Categorical Exclusion

Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

CATEGORICAL EXCLUSION APPENDIX, NUMBER, AND DESCRIPTION: B5.16 Solar Photovoltaic Systems (a) The installation, modification, operation, or decommissioning of commercially available solar photovoltaic systems: (1) Located on a building or other structure (such as rooftop, parking lot or facility, or mounted to signage, lighting, gates, or fences); or (2) Located within a previously disturbed or developed area. (b) Covered actions would be in accordance with applicable requirements (such as land use and zoning requirements) in the proposed project area and the integral elements listed at the start of appendix B of this part, and would be consistent with applicable plans for the management of wildlife and habitat, including plans to maintain habitat connectivity, and incorporate appropriate control technologies and best management practices.

B4.14 Construction and Operation of Electrochemical-Battery or Flywheel Energy Storage SystemsConstruction, operation, upgrade, or decommissioning of an electrochemical-battery or flywheel energy storage system within a previously disturbed or developed area or within a small (as discussed at 10 CFR 1021.410(g)(2)) area contiguous to a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as land use and zoning requirements) in the proposed project area and the integral elements listed at the start of appendix B of this part, and would incorporate appropriate safety standards (including the current National Fire Protection Association 855, Standard for the Installation of Stationary Energy Storage Systems), design and construction standards, control technologies, and best management practices.

Rationale for Determination: The \$15 million Energizing Rural Communities (ERC) Prize challenges individuals and organizations to develop partnership plans (the partner track) or innovative financing strategies (the finance track) to help rural or remote communities improve their energy systems and advance clean energy demonstration projects. This prize is part of the \$1 billion Energy Improvements in Rural or Remote Areas (ERA) Program, created by the U.S. Department of Energy's Office of Clean Energy Demonstrations (OCED). The ERA Program supports projects that improve the resilience, reliability, safety, availability, and environmental performance of energy systems in rural or remote areas of the U.S. with populations of no more than 10,000 people. The application period for Phase 2 of the ERC prize closed in July 2024.

Uhe Solar United National (SUN) Rural Solar Project & Workforce Development activities would include: installing a carport roof top solar installation with two loop chargers and a 18 kWh resilience battery, completing community outreach and developing partnerships, and providing workforce and community training opportunities. The batteries are six lithium-ion Generac model G0080040 PWRcell 3 kWh modules. This battery type meets the fire safety standards through compliance under UL 1973.

DOE has analyzed the potential effects of the total project and determined that the proposed project fulfills all conditions, including integral elements of each categorical exclusion applied in this CX determination. DOE has considered potential impacts on resources, including those of an ecological, historical, and cultural nature. DOE does not anticipate adverse impacts to any sensitive resources because of the proposed activities.

⊠The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not:

- (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B (4) of 10 CFR Part 1021, Subpart D, Appendix B;
- (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B (5) of 10 CFR Part 1021, Subpart D, Appendix B.

⊠There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal. The proposed action has not been segmented to meet the definition of a categorical exclusion.
