Dear Ms. Sweeney:

On August 16, 2024, Driftwood LNG LLC (“Driftwood LNG”) submitted a Statement of Change in Control (“Statement”) to the U.S. Department of Energy (“DOE”), Office of Fossil Energy and Carbon Management (“DOE/FECM”).<sup>1</sup> In the Statement, Driftwood LNG provided notice of an anticipated change in its upstream ownership (“Proposed Transaction”), consistent with DOE’s Change in Control Procedures,<sup>2</sup> and indicated that it would promptly notify DOE/FECM after close of the Proposed Transaction.

On September 26, 2024, DOE/FECM issued Order No. 5173,<sup>3</sup> approving Driftwood LNG’s change in control, effective upon the close of the Proposed Transaction. Driftwood LNG hereby provides notice that the Proposed Transaction closed on October 8, 2024.
