**Long-Term Supply Contract** 

Dear Ms. Sweeney:

Sabine Pass Liquefaction, LLC ("Sabine Pass") hereby submits¹ for filing under seal, a non-redacted copy of the NAESB Base Contract for Sale and Purchase of Natural Gas (as may have been amended from time to time, the "Base Contract") and the Transaction Confirmation ("Confirmation"), entered into by Sabine Pass on September 30, 2015 and October 10, 2024 (respectively) with Southwest Energy, L.P. ("Counterparty"). Under the Base Contract and Confirmation, Counterparty will sell and Sabine Pass will purchase natural gas on a long-term basis. Sabine Pass intends to liquefy the natural gas purchased from Counterparty at the Sabine Pass LNG facilities.

Sabine Pass is also filing herewith a public summary of the major provisions of the Base Contract and Confirmation. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy and Carbon Management ("DOE/FECM") Order Nos. 2833, 2961-A, 3306, 3307, 3384, 3595, 3669, 3792, 4520 & 4800 (each as may have been amended).<sup>2</sup> Sabine Pass hereby requests confidential treatment of the Base Contract and

Approximately 27,500,000 MMBtu

### 7. Take or Pay Provisions:

Pursuant to the terms of the contract, in respect of any day, the Seller is obliged to deliver to Buyer a specified quantity of gas, or compensate the Buyer if not made available, unless otherwise excused under the contract. Similarly, in respect of any day, the Buyer is obliged to take a specified quantity of gas, or compensate the Seller if not taken, unless otherwise excused under the contract.
