Dear Ms. Sweeney:

Sabine Pass Liquefaction Stage V, LLC (“Sabine Pass V”) and Sabine Pass Liquefaction, LLC (“SPL” and together with Sabine Pass V, “Sabine Pass”) hereby submit¹ for filing under seal, a non-redacted copy of the Gas Supply Agreement (the “Contract”) entered into by Sabine Pass V on September 27, 2023 with ARC Resources U.S. Corp. (“Counterparty”). Under the Contract, Counterparty will sell and Sabine Pass V will purchase natural gas on a long-term basis. Sabine Pass V intends to liquefy the natural gas purchased from Counterparty at the Sabine Pass LNG Terminal.

Sabine Pass is also filing herewith a public summary of the major provisions of the Contract. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy and Carbon Management (“DOE/FECM”) Order No. 5181 (as may have been amended).² Sabine Pass hereby request confidential treatment of the Contract filed herewith, as it contains commercially sensitive information.

**GAS SUPPLY AGREEMENT, DATED SEPTEMBER 27, 2023,
BETWEEN SABINE PASS LIQUEFACTION STAGE V, LLC AND
ARC RESOURCES U.S. CORP.**

Similarly, in respect of any day, the Buyer is obliged to take a specified quantity of gas, or compensate the Seller if not taken, unless otherwise excused under the contract.
