Notification of Entity and Project Name Change and Request to Update
Service List**

Dear Ms. Sweeney:

On August 16, 2024, Driftwood LNG LLC (“Driftwood LNG”) submitted a notice to the U.S. Department of Energy’s (“DOE”) Office of Fossil Energy and Carbon Management (“DOE/FECM”) regarding an anticipated change in Driftwood LNG’s upstream ownership.¹ On September 26, 2024, DOE/FECM issued an order,² approving Driftwood LNG’s change in control immediately upon closing of the transaction. On October 21, 2024, Driftwood LNG submitted a notice to DOE/FECM confirming Woodside Energy Group Ltd’s (“Woodside Energy”) acquisition of Tellurian Inc.³

Woodside Energy hereby provides notification of additional changes regarding the entity reflected in Driftwood LNG’s DOE Authorizations.⁴ Please be advised that on November 20, 2024, Driftwood LNG filed a Certificate of Amendment with the state of Delaware, changing its name to “Louisiana LNG Infrastructure LLC” (“Louisiana LNG”).⁵ In this regard, Woodside Energy has established a new name for the “Driftwood LNG Project”, and herein notifies DOE/FECM the project name is now the “Woodside Louisiana LNG Project.”

Louisiana LNG therefore requests that DOE/FECM amend its DOE Authorizations to reflect its corporate name change. There are no changes related to upstream ownership as authorized by DOE/FECM in Order No. 5173, and the amendment requested herein represents a change in name only.

In addition to the changes described above, Louisiana LNG requests that DOE/FECM update the official service list to reflect the updated contact information below:
