Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to authorize the administration of Round 3 of a prize competition (The Community Power Accelerator Prize, or Prize) designed to fast-track the efforts of new, emerging, and expanding solar developers and co-developers to learn, participate in, and grow a successful portfolio of community-benefiting distributed solar projects. The scope of work solicited under this three-phase Prize is limited exclusively to outreach, education, training, and data analysis. Such activities are expected to be conducted from existing offices and meeting space and would not require any materials beyond basic office supplies and computers. DOE has considered the nature of the proposed activities to determine potential impacts on sensitive resources, including those of a biological, ecological, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
