**Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:**

Description:

**A1 Routine DOE business actions** Routine actions necessary to support the normal conduct of DOE business limited to administrative, financial, and personnel actions.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the National Archives and Records Administration (NARA) as part of the Assisting Federal Facilities with Energy Conservation Technologies (AFFECT) grant program. The funding provided would assist in energy efficiency upgrades at Archive I in Washington, DC and Archive II in College Park, MD.

AFFECT funding for this award would total \$2,000,000 and would be applied to upgraded control systems, heating and cooling systems, lighting and electrical systems, and water conservation. This National Environmental Policy Act (NEPA) Determination applies to the distribution of funds only. Because NARA is a federal agency, it is required to comply with NEPA for this project. This would include completing an environmental review for the project, including any necessary consultations and geotechnical or other surveys prior to a decision whether to proceed. If NARA proceeds with the proposed project after their NEPA review, they would be required to obtain all necessary permits and follow appropriate environmental, health, and safety measures. NARA must provide its final NEPA Determination(s) to their DOE Federal Energy Management Program (FEMP) Technical Project Officer (TPO) or point of contact.

**NEPA PROVISION**

DOE has made a final NEPA determination.

Because NARA is a federal agency, it is required to comply with the National Environmental Policy Act (NEPA). When NARA has completed its NEPA review process for the proposed project, NARA would provide its final NEPA Determination(s) to their DOE FEMP TPO or point of contact.

**FOR CATEGORICAL EXCLUSION DETERMINATIONS**

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
