Description:

Rationale for determination:

The U.S. Department of Energy (DOE) Office of Indian Energy Policy and Programs Office (IE) is proposing to issue a Funding Opportunity Announcement (FOA) (DE-FOA-0003403). The FOA intends to provide financial support to Tribal Colleges and Universities (TCUs) to plan the transition of their campuses to clean energy.

All selected awards would be strictly administrative and limited to activities of intellectual, academic, or analytical in nature. No field deployments, installations, or other physical activities would be included in award activities. Anticipated award activities would include, but are not limited to, administrative tasks such as planning, feasibility assessments, education, outreach, design work, desktop tasks, and research.

Participating entities would be identified as part of award selection processes. As such, award recipients and locations are not yet known. Despite this, further NEPA review would not be required for activities of selected awards under this FOA provided that all activities are consistent with the activity descriptions in this NEPA Determination.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

NEPA PROVISION

DOE has made a final NEPA determination.

Include the following condition in the financial assistance agreement:

This NEPA Determination applies to the issuance of the FOA as well as all awards selected under the FOA, provided the scope of the selected awards remains consistent with the intent of the FOA, as issued. If selected applicants propose to use project funds for activities outside the scope of this NEPA Determination, additional NEPA review will be required.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
