Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the Regents of the University of California at Riverside to identify and address permitting challenges for the deployment of hydrogen technologies.

Award activities would take place over two budget periods and would include gathering and analyzing permit process information for multiple hydrogen technologies, conducting safety and risk assessments of technologies and configurations, consulting with permitting authorities, and creating Safety & Permitting Guide documents to streamline the permitting process and provide resources for stakeholders and communities.

Award activities would be carried out by CE-CERT (Riverside, CA), Sandia National Laboratories (Albuquerque, NM), GHD (Irvine, CA), and Hydrogen Technologies, LLC (Tulsa, OK).

Award activities would be intellectual, academic, or analytical in nature and would occur entirely within existing research and development facilities that are purpose-built for the type and scale of activities being proposed. No change in the use, mission, or operation of existing facilities would arise out of this effort.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
