

Proposed Action Title: N-Area Tornado Shelters Installation

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Installation of two tornado shelters inside N-Area. One will be West of 704-1N and the other will be South of 731-2N.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
