Proposed Action Description:

This EEC supports activities post Cold & Dark status of Building 235-F. Revision 6 includes work in 701-1F, 720-F, 252-9F, and removal of perimeter fencing and PIDAS.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
