Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to GE Vernova Operations LLC. (Vernova) to for development of a computer based artificial intelligence (AI) assistant (HySAGE) for hydrogen (H2) permitting and safety training for H2 deployment.

Award activities would occur over two budget periods (BP). BP1 would include project management and planning, development of framework functionality, development of H2 emergency preparedness, and community benefits. BP2 would include project management and planning, H2 workforce development, community benefits, HySAGE refinement and deployment, and final reporting.

Award activities would occur at Roper Mountain Science Center (RMSC) in Greenville, SC; Vernova's Gas Turbine Technology Laboratory in Greenville, SC; Clemson University in Clemson, SC; and Savannah River National Laboratory in Aiken, SC.

The proposed award activities would involve development of the HySAGE AI assistant, an industrial level training for hydrogen knowledge and safety, and development of H2 exhibits for school age children, including procurement of durable lab equipment for use in middle school classes at the RMSC Hoffman Electrolysis Demonstration Laboratory.

Award activities would occur entirely within existing research and development facilities that are purpose-built for the type and scale of activities being proposed. No change in the use, mission, or operation of existing facilities would arise out of this effort.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.
