Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to RTI International (RTI) for design, development, fabrication, and testing of LED luminaries that could be retrofitted into existing high-use buildings.

Award activities would occur over two budget periods (BP). BP1 would include identification of LED packages, investigation of fixture designs, and identification of sustainable materials for LED fixtures and LED drivers. BP2 would

include LED fixture assembly, testing, optimization, identification of electrical components, third-party validation, and project management and reporting.

Material, component, and device testing would occur at RTI International Headquarters, a complex of laboratories and office space in Durham, NC. Design, development, and fabrication activities would be performed by Finelite at their research and development (R&D) facility in Union City, VA. Award activities would occur entirely within existing, fully permitted R&D facilities that are purpose-built for the type and scale of activities being proposed. No change in the use, mission, or operation of existing facilities would arise out of this effort.

Hazards associated with this award would involve testing and analysis of solid-state lighting (SSL) and components. All such devices would be handled and tested in-lab following proper hazardous material management and disposal practices in accordance with RTI practices. Existing corporate health, safety, and environmental policies, procedures, and regulations would be followed, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.
