Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B2.4 Equipment Qualification

Activities undertaken to (1) qualify equipment for use or improve systems reliability or (2) augment information on safety-related system components. These activities include, but are not limited to, transportation container qualification testing, crane and lift-gear certification or recertification testing, high efficiency particulate air filter testing and certification, stress tests (such as "burn-in" testing of electrical components and leak testing), and calibration of sensors or diagnostic equipment.

B3.6 Small-scale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to SLB to develop and validate a fully functional wireline conveyance tool and downhole cement/casing evaluation system that expands upon existing oil and gas technologies for application in higher temperature geothermal environments. The expected outcome is a working prototype that is ready for future field trials. Field testing is outside the scope of work under this award.

The types of activities associated with the proposed project would be limited to data analysis, computer modeling, preliminary engineering, and laboratory research. Project activities would occur at SLB technology centers in Sugar Land, TX, and Clamart, France, as well as subrecipient Sandia National Laboratories in Albuquerque, NM. Some tool components may be sourced from qualified third-party industrial manufacturers if necessary.

Materials used by the project would include primarily machined metallic components (e.g., pipes, tubes, springs, screws) electronics (e.g., wiring, circuit boards, motors, controllers) and a relatively minor number of other components (e.g., seals, adhesives, grease, lubricants). Manufacturing processes would consist of standard metal machining and electrical connection/soldering. The end product is anticipated to be a roughly cylindrical metal tool on the order of 3-9 inches in diameter, roughly 20 feet long, and weighing 300-500 pounds that can be dropped into a wellbore via a metal cable.

The proposed project locations were purpose-built for the type of activities being proposed; therefore, no modifications or new permits would be required. No change in the use, mission, or operation of existing facilities would arise out of this effort. DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of a biological, ecological, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.
