Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Innovative Downhole Solutions, Inc. (IDS) to design, develop, and test an ultrasonic measurement tool for downhole well integrity evaluation.

The project would be completed over three Budget Periods (BPs) and thirteen Tasks. The project field testing site has not yet been determined. As such, this NEPA Determination only applies Tasks 1-12. Proposed activities during Tasks 1-12 would include modeling, material procurement, design and fabrication, reporting, electrical design, data processing, algorithm development, software development, and assembling and laboratory testing the prototype tool. At this time, there insufficient information related to Task 13 to perform a meaningful NEPA review as location information for this Subtask is currently undefined and is reliant on information gathered in Tasks 1-12, such as site and design specifications.

Award activities including design, development, fabrication, and laboratory testing would be carried out by IDS (Houston, TX), with data processing and modeling provided by University of Houston (Houston, TX).

Individuals working on this project could be exposed to physical hazards, such as machinery, hand tools, cutting fluid, cleaners, and degreasers. Existing corporate health and safety policies and procedures would be followed including employee training, proper protective equipment, and engineering controls.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
