Proposed Action Title: National Renewable Energy Laboratory -- USFLOWT: Ultraflexible Smart FLoating Offshore Wind Turbine

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities of an advanced wind turbine with ultra-flexible and light blades, advanced aerodynamic control surfaces, and a revolutionary substructure: the SpiderFLOAT. Under Phase II of this project under the Aerodynamic Turbines Lighter and Afloat with Nautical Technologies and Integrated Servo-control (ATLANTIS) Program, the project team will (1) design and build a sub-scale model based on Phase I project outcomes, (2) test model in a controlled wave tank (3) analyze and apply adjustments to model design, and (4) develop design for full-scale turbine. If successful, the project will result in an innovative system to unlock the floating offshore wind market by lowering the cost of energy below the value of fixed-bottom offshore wind plants (7.5 ¢/kWh).

Project activities will be conducted at existing facilities at National Renewable Energy Laboratory (Golden, CO), American Bureau of Shipping (Houston, TX), Floating Wind Technology (Arvada, CO), Front Energies (Houston, TX), and Naval Surface Warfare Center, Carderock Division (Potomac, MD) designed for the applicable activities. The project team has certified that (a) project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements, and (b) no modifications will be made to existing facilities to accommodate the proposed work.
