Proposed Action Description:

This EEC covers the evaluation and corrections of HVAC compressors units in 773-A.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

 \square The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
