Description:

<b>A9 Information gathering, analysis, and dissemination</b>	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)
<b>A11 Technical advice and assistance to organizations</b>	Technical advice and planning assistance to international, national, state, and local organizations.
<b>B5.16 Solar photovoltaic systems</b>	The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

## Rational for determination:

DOE is proposing to provide federal funding to the California Community College to continue advancing the Solar Instructor Training Network (SITN). DOE funding would be used to implement internet-based "train the trainer" courses for photovoltaics (PV) and ongoing professional development and networking opportunities for trainees and other key partners.

DOE made a previous NEPA determination for Phase 1 (GF0-10-165; CX A9, A11 and B5.1; signed 2.1.2010), which involved curriculum development and the establishment of programs through instructor training. This NEPA determination applies to Phase 2 – 4.

Phase 2 – 4 would continue to facilitate the creation of a well-trained, solar energy workforce by selecting additional institutions to include in the SITN. At the selected institutions, instructors would teach the developed curriculum using existing equipment already at the schools. The proposed project would include hands-on training for PV and on-going professional development and networking opportunities for trainees and other key partners within the multi-state region.

Based on this information, DOE has determined the work outlined is consistent with activities identified in A9 (Information gathering, analysis and dissemination), A11 (technical advice and assistance) and B5.16 (solar photovoltaic systems).
