ORDER GRANTING REQUEST TO AMEND DOE/FE ORDER NO. 3252 AND PENDING APPLICATION TO REFLECT CORPORATE NAME CHANGE

DOE/FE ORDER NO. 3252-A

I. BACKGROUND

On January 10, 2013, the entity then-known as Trunkline LNG Export, LLC (TLNG Export) filed an application (Application)1 with the Office of Fossil Energy (FE) of the Department of Energy (DOE) under section 3 of the Natural Gas Act (NGA)² requesting longterm, multi-contract authorization to export liquefied natural gas (LNG) produced from domestic sources in a volume equivalent to approximately 730 billion cubic feet per year (Bcf/yr) of natural gas (2.0 Bcf per day) for a 25-year term. TLNG Export requested authorization to export this LNG by vessel from the Lake Charles LNG Terminal (Lake Charles Terminal), located in Lake Charles, Louisiana, and owned and operated by TLNG Export's affiliate then-known as Trunkline LNG Company, LLC. TLNG Export sought to export the LNG on its own behalf and as agent for other entities to: (1) any country with which the United States currently has, or in the future will have, a free trade agreement (FTA) requiring national treatment for trade in natural gas, and with which trade is not prohibited by U.S. law or policy (FTA countries), and (2) any country with which the United States does not have a free trade agreement (FTA) requiring national treatment for trade in natural gas and with which trade is not prohibited by U.S. law or policy (non-FTA countries).

On March 7, 2013, DOE/FE issued Order No. 3252, granting the portion of the Application requesting authorization to export LNG to FTA countries.³ The portion of the

Application requesting authorization to export LNG to non-FTA countries is still pending in the above-captioned docket.

II. DESCRIPTION OF REQUEST

On October 10, 2014, TLNG Export submitted a letter notifying DOE/FE of a corporate name change. Specifically, on September 19, 2014, TLNG Export amended its Certificate of Formation with the state of Delaware to change its name to "Lake Charles LNG Export Company, LLC." TLNG Export states that this is strictly a name change, and there has been no change in the ownership, control, or corporate structure of the company. 5

In light of this corporate name change, and pursuant to DOE's regulations (10 C.F.R. § 590.204), TLNG Export asks DOE/FE to take the following actions: (1) to issue an order amending the named authorization holder in DOE/FE Order No. 3252 to Lake Charles LNG Export Company, LLC; and (2) to accept its notice as an amendment of the pending non-FTA application naming Lake Charles LNG Export Company, LLC as the applicant.

Finding good cause for both actions, DOE/FE hereby grants the requests.

ORDER

Pursuant to section 3 of the Natural Gas Act, 15 U.S.C. § 717b, it is ordered that:

- A. The name of the authorization holder of DOE/FE Order No. 3252 is hereby amended to Lake Charles LNG Export Company, LLC.
- B. The name of the applicant in the Application pending in FE Docket No. 13-04-LNG is hereby amended to Lake Charles LNG Export Company, LLC.

C. All obligations arising under DOE/FE Order No. 3252, and under any future DOE/FE authorization granted in FE Docket No. 13-04-LNG, apply to Lake Charles LNG Export Company, LLC.
