Re: Louisiana LNG Energy, LLC, FE Docket No. 14-019-LNG and FE Docket No. 14-029-LNG, Notice of Change in Control

Dear Mr. Anderson:

On February 5, 2014, Louisiana LNG Energy, LLC (“LLNG”) filed an application for authorization to export two million metric of LNG per year for a term of 25 years to Free Trade Agreement countries (“FTA Application”). On February 18, 2014, LLNG filed an application for authorization to export two million metric of LNG per year for a term of 25 years to Non-Free Trade Agreement countries (“Non-FTA Application”). LLNG filed a supplement to each of the applications on July 24, 2014. On August 28, 2014, the Department of Energy Office of Fossil Energy (“DOE/FE”) granted LLNG authorization to export LNG to Free Trade Agreement countries in Order No. 3482 (“FTA Authorization”). The Non-FTA Application is currently pending in Docket No. 14-029-LNG.

Through this Notice of Change in Control, LLNG is hereby (i) amending the FTA Authorization and (ii) requesting approval of an amendment to the Non-FTA Application pursuant, in each case to reflect the acquisition of LLNG by Parallax Enterprises (NOLA) LLC (“Parallax NOLA”). This Notice of Change in Control is provided pursuant to DOE/FE’s Procedures for Change in Control Affecting Applications and Authorizations to Import or Export Natural Gas.¹

On April 22, 2015, Parallax NOLA acquired all of the outstanding membership interests of LLNG. The sole member of Parallax NOLA is Parallax Enterprises LLC ("Parallax Enterprises"), and the sole member of Parallax Enterprises is Parallax Energy LLC ("Parallax"). Each of Parallax NOLA, Parallax Enterprises, and Parallax is a limited liability company formed under the law of Delaware with its principal place of business at 1201 Louisiana Street, Suite 580, Houston, Texas 77002. Martin Houston is the founding partner and Chairman of Parallax.

Parallax is an energy firm that consists of an accomplished team of industry leaders in the global energy market, with over 100 collective years experience in the LNG industry. The company's investment activities include the development of global LNG projects and a gas supply and trading business.
