NOTICE OF CORPORATE REORGANIZATION OR CHANGE IN CONTROL AND
AMENDMENT OF PENDING APPLICATION TO EXPORT LIQUEFIED NATURAL GAS
TO NON-FREE TRADE AGREEMENT COUNTRIES

Notice is hereby given that the U.S. Department of Energy, Office of Fossil Energy (DOE/FE), authorizes Louisiana LNG Energy LLC (LLNG) to amend the named applicant in the above-captioned proceeding, as discussed below and requested in a Notice of Change in Control submitted by LLNG on May 21, 2015 (Notice).¹

On February 18, 2014, LLNG submitted an application (Application) to DOE/FE requesting authorization to export liquefied natural gas (LNG) in a volume equivalent to approximately 103.4 billion cubic feet per year of natural gas to countries with which the United States does not have a free trade agreement (FTA) requiring national treatment for trade in natural gas, and with which trade is not prohibited by U.S. law or policy (non-FTA countries). That Application remains pending in FE Docket No. 14-29-LNG.

In the Notice, LLNG requests approval to change the applicant in this proceeding from LLNG to an entity named Parallax Enterprises (NOLA) LLC (Parallax NOLA), due to a

corporate reorganization or change in control. Specifically, LLNG states that, on April 22, 2015, Parallax NOLA acquired all of the outstanding membership interests of LLNG. LLNG further states that Parallax NOLA has a single member, Parallax Enterprises LLC, which in turn has a sole member, Parallax Energy LLC. According to LLNG, Parallax Energy LLC is an energy firm with investment activities that include the development of global LNG projects and a gas supply and trading business. Each of these three entities—Parallax NOLA, Parallax Enterprises LLC, and Parallax Energy LLC—is a Delaware limited liability company with its principal place of business in Houston, Texas.

LLNG states that it served a copy of the Notice on all persons on the official service list for this proceeding. Additionally, DOE/FE posted the Notice in the electronic docket for this proceeding. No responses or answers in opposition have been received. DOE/FE has reviewed LLNG's Notice and finds that it has not been shown that amending the Application is inconsistent with the public interest. 15 U.S.C. § 717b(a). Accordingly, pursuant to DOE/FE's Revised Procedures for a Change in Control² and its regulations at 10 C.F.R. § 590.204, LLNG's Application has been granted and given effect. Parallax Enterprises (NOLA) LLC is hereby named the new applicant in the non-FTA export proceeding pending in FE Docket No. 14-29-LNG.
