Re: Request to Correct Errata in DOE/FE Order No. 3639 Pieridae Energy (USA) Ltd., FE Docket No. 14-179-LNG

Dear Mr. Anderson:

In accordance with the Department of Energy's ("DOE") Rule 590.103(a)¹ and other applicable DOE regulations, Pieridae Energy (USA) Ltd. ("Pieridae"), by and through its attorneys – Norton Rose Fulbright US LLP, hereby submits its Request to Correct Errata with respect to the matters described below.

On October 24, 2014, Pieridae submitted an application to the DOE, Office of Fossil Energy (the "DOE/FE") requesting long-term, multi-contract authorization to export natural gas (1) into Canada for consumption in Canada, and (2) through Canada to countries with which the United States of America has entered into a free trade agreement requiring national treatment for trade in natural gas ("FTA Countries") and to countries with which the United States of America has not entered into a free trade agreement but with which trade is lawful ("Non-FTA Countries"). In the case of item (2), the natural gas would be converted into liquefied natural gas ("LNG") in Canada prior to being sent on to other FTA or Non-FTA Countries. On May 8, 2015, Pieridae submitted a supplement to the Application, in which Pieridae requested authority to export natural gas as an agent for other entities, in addition to exporting the natural gas on its own behalf, to FTA and Non-FTA Countries.

On May 22, 2015, DOE/FE issued Order No. 3639 granting Pieridae's requests for authorization to export natural gas from the United States of America to FTA Countries.⁵ Pieridae respectfully requests the following two errata items contained in Order 3639 be corrected:

First, page 6, paragraph 2, sentence 1 in Section II (Background) of Order 3639 reads: "Pieridae states that it will source natural gas from the United States and Canada for use as feedstock in the production of LNG from Train 2 for export to its customers." This statement suggests that all of the natural gas exported by Pieridae will be converted into LNG and then exported to Pieridae's customers. This is not consistent with the other uses described in Pieridae's filings or other portions of Order 3639. Pieridae respectfully requests DOE/FE issue an errata notice to correct this sentence to read: "Pieridae states that it will source natural gas from the United States either for use as feedstock in the production of LNG from Train 2 for export to its customers or for sale, in whole or in part, to one or more other entities including, Pieridae CA."

Second, page 12, Ordering Paragraph A, sentence 1, Order 3639 states: "Pieridae is authorized to export U.S.-sourced natural gas by pipeline from the United States to Canada for end use in Canada and/or, after liquefaction in Canada, by vessel from the proposed Goldboro LNG Project, to be located in Halifax, Nova Scotia, Canada, to FTA countries for end use in FTA countries." (emphasis added). As noted in Pieridae's prior filings, the Goldboro LNG Project is to be located in what is popularly referred to as "Guysborough County" (the formal legal name being "Municipality of the District of Guysborough"). Pieridae respectfully requests DOE/FE issue an errata notice to correct this sentence to read: "Pieridae is authorized to export U.S.-sourced natural gas by pipeline from the United States to Canada for end use in Canada and/or, after liquefaction in Canada, by vessel from the proposed Goldboro LNG Project, to be located in the Municipality of the District of Guysborough, Nova Scotia, Canada, to FTA countries for end use in FTA countries."


