NOTICE OF CORPORATE REORGANIZATION OR CHANGE IN CONTROL
AND AMENDMENT OF AUTHORIZATIONS TO EXPORT LIQUIFIED NATURAL GAS
TO FREE TRADE AGREEMENT COUNTRIES

Notice is hereby given that Venture Global LNG, LLC (Venture Global), the applicant in the above-captioned proceedings, is authorized to implement a corporate reorganization or other change in control and to amend the named authorization holder in both proceedings, as requested in an application submitted on September 22, 2014 (Application), to the U.S. Department of Energy, Office of Fossil Energy (DOE/FE).¹

Currently, Venture Global holds two authorizations to export liquefied natural gas (LNG) to countries with which the United States has a free trade agreement (FTA) requiring national treatment for trade in natural gas and with which trade is not prohibited by U.S. law or policy

Venture Global asserts that the corporation reorganization will change the identity of the authorization holder without any change in control or any change in aspects of Venture Global's proposed LNG export project.

(FTA countries): DOE/Order No. 3345 in FE Docket No. 13-69-LNG,² and DOE/Order No. 3520 in FE Docket No. 14-88-LNG.³

In the Application, Venture Global describes a corporate reorganization or change in control and proposes to change the holder of both FTA authorizations from Venture Global to a new entity named Venture Global Calcasieu Pass, LLC.⁴ Venture Global states that Venture Global Calcasieu Pass, LLC, is a wholly-owned, single-purpose subsidiary created to facilitate the financing and development of the proposed LNG export project described in the two proceedings. According to Venture Global, Venture Global Calcasieu Pass, LLC is a Delaware limited liability company with its principal place of business in Washington, D.C. (the same as Venture Global).

DOE/FE has reviewed Venture Global's request to amend the holder of its two FTA authorizations, and found that the request is deemed consistent with the public interest pursuant to section 3(c) of the Natural Gas Act, 15 U.S.C. § 717b(c). Accordingly, pursuant to the Office of Fossil Energy's Revised Procedures for a Change in Control⁵ and DOE's regulations at 10 C.F.R. § 590.405, Venture Global's Application has been granted and given effect as to the FTA authorizations. Venture Global Calcasieu Pass, LLC is hereby named the new authorization holder in DOE/Order No. 3345 (FE Docket No. 13-69-LNG) and DOE/Order No. 3520 (FE Docket No. 14-88-LNG). All obligations arising under those two authorizations no longer
