NOTICE OF CORPORATE REORGANIZATION OR CHANGE IN CONTROL AND AMENDMENT FOR PENDING APPLICATIONS TO EXPORT LIQUIFIED NATURAL GAS TO NON-FREE TRADE AGREEMENT COUNTRIES

Notice is hereby given that Venture Global LNG, LLC (Venture Global), the applicant in the above-captioned proceedings, is authorized to implement a corporate reorganization or other change in control and to amend the named applicant in both proceedings, as requested in an application submitted on September 22, 2014 (Application), to the U.S. Department of Energy, Office of Fossil Energy (DOE/FE).

Currently, Venture Global is the applicant in two proceedings pending before DOE/FE (FE Docket Nos. 13-69-LNG and 14-88-LNG) requesting authorization to export liquefied natural gas (LNG) to countries with which the United States does not have a free trade agreement (FTA) requiring national treatment for trade in natural gas and with which trade is not prohibited by U.S. law or policy (non-FTA countries). In the Application, Venture Global describes a corporate reorganization or change in control and proposes to change the applicant in both non-FTA proceedings from Venture Global to a new entity named Venture Global Calcasieu Pass,

Venture Global asserts that the corporation reorganization will change the identity of the applicant for authorization without any change in control or any change in aspects of Venture Global's proposed LNG export project.

LLC.<sup>2</sup> Venture Global states that Venture Global Calcasieu Pass, LLC, is a wholly-owned, single-purpose subsidiary created to facilitate the financing and development of the proposed LNG export project described in the two proceedings. According to Venture Global, Venture Global Calcasieu Pass, LLC is a Delaware limited liability company with its principal place of business in Washington, D.C. (the same as Venture Global).

Venture Global provided a certificate of service with its Application stating that it had served a copy of the Application on all persons on the official service list in both proceedings. No responses or answers in opposition to the Application have been received. DOE/FE has reviewed the Application and finds that it has not been shown that Venture Global's notice of the corporate reorganization or other change in control and proposed amendment is inconsistent with the public interest. 15 U.S.C. § 717b(a). Accordingly, pursuant to the Office of Fossil Energy's Revised Procedures for a Change in Control<sup>3</sup> and DOE's regulations at 10 C.F.R. § 590.204, Venture Global's Application has been granted and given effect. Venture Global Calcasicu Pass, LLC is hereby named the new applicant in the two pending non-FTA export proceedings captioned above.
