Update and Supplement to Applications re. Lease Option Agreement

Dear Sirs & Madams:

Venture Global Calcasieu Pass, LLC ("Calcasieu Pass") hereby submits to the Department of Energy, Office of Fossil Energy ("DOE/FE") this supplement to its pending applications in FE Docket Nos. 13-69-LNG and 14-88-LNG 1/ for long-term, multi-contract authorization to export of LNG to countries with which the United States does not have a Free-Trade Agreement requiring the national treatment of natural gas of liquefied natural gas. Calcasieu Pass hereby provides a copy of the Amended and Restated Lease Option Agreement for its approximately two hundred and three (203) acre project site in Cameron Parish, Louisiana.

Calcasieu Pass previously submitted to DOE/FE three lease option agreements for a total of one-hundred and nine (109) acres of its project site.2/ As Calcasieu Pass explained in its October 1, 2014 update to these proceeding, Calcasieu Pass had also entered into an exclusive agreement that contemplates a lease option agreement for an additional ninety-three (93) acres, contiguous with the acreage already secured in the previously filed agreements, resulting in a total project site of approximately two hundred and three (203) acres. Calcasieu Pass further explained in that update that it expected to consolidate the land covered by that latest agreement together with all the land covered by the three lease option agreements into a single lease option agreement.

1/ These applications were originally filed by Venture Global LNG, LLC. Calcasieu Pass was recognized as the current applicant in the "Notice of Corporate Reorganization or Change in Control And Amendment For Pending Applications To Export Liquefied Natural Gas To Non-Free Trade Agreement Countries," issued in the captioned proceedings on Nov. 26, 2014.

2/ The three lease option agreements were provided as an attachment to the application in Docket 14-88-LNG, as well as in a supplement filed in Docket 13-69-LNG on December 12, 2013.

The consolidation of the option arrangements in relation to all of the land comprising the project site, previously covered by the three previously filed lease option agreements and the additional agreement, has been accomplished pursuant to the attached Amended and Restated Real Estate Lease Option Agreement, which was executed on November 20, 2014. As with its previously filed lease option agreements, Calcasieu Pass has redacted certain confidential terms from the Amended and Restated Lease Option Agreement filed herewith.
