A RESOLUTION OF SUPPORT FOR CAMERON LNG'S REQUEST TO DOE TO APPROVE ADDITIONAL 2.95 MTPA CAPACITY FOR EXPORT TO NON-FTA COUNTRIES.

**WHEREAS**, the Cameron Parish Policy Jury supports the construction of Cameron LNG's three-train liquefaction facility in Hackberry, LA; and,

**WHEREAS**, the Cameron LNG liquefaction project will use the existing facility, including two marine berths capable of accommodating Q-Flex sized LNG ships, three LNG storage tanks with a combined storage capacity of 480,000 cubic meters, and vaporization capability for regasification services of 1.5 billion cubic feet per day; and,

**WHEREAS**, Cameron LNG obtained approval from the US Department of Energy to export up to 12 million tonnes per annum (mtpa), or approximately 1.7 billion cubic feet per day of domestically produced liquefied natural gas to all current and future Free Trade Agreement and non-Free Trade Agreement countries; and,

**WHEREAS**, the US Federal Energy Regulatory Commission authorized Cameron LNG to site, construct and operate the Liquefaction Project facilities under Section 3 of the Natural Gas Act and Issuing Certificates, 147 FERC ¶ 61,230 (June 19, 2014), with an aggregate maximum liquefaction capacity of the Liquefaction Project facility under optimal conditions of 14.94 mtpa; and,


**WHEREAS**, Cameron LNG requested and obtained approval from the US Department of Energy to export an additional 2.95 mtpa, or approximately 0.41 billion cubic feet per day of domestically produced liquefied natural gas to all current and future Free Trade Agreement countries, and, has a request pending to non-Free Trade Agreement countries for this additional capacity at FE Docket No. 15-67-LNG, which represents the difference between the approved DOE authorization of 12 mtpa and the maximum capacity of the facility as approved by FERC in June 2014 (14.95 mtpa); and,

**WHEREAS**, the Cameron LNG export facility, currently under construction, is providing a boost to Louisiana's local and regional economy through indirect increases in resource development, an enhanced tax base, direct and indirect job creation and increased economic activity. Over 140 permanent new quality jobs will be created at Cameron LNG, many of these prior to the end of construction, and these jobs will directly benefit Louisiana's economy and specifically, Cameron Parish; and,

**NOW, THEREFORE, BE IT RESOLVED**, that the Cameron Parish Policy Jury does hereby support Cameron LNG's liquefaction project and in particular, Cameron LNG's request to DOE to approve the additional 2.95 mtpa capacity for export to non-FTA countries, and the Secretary is authorized to send this resolution to the US Department of Energy.




