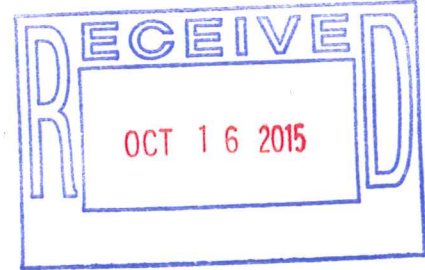

Dear Mr. Anderson,

I am writing in support of Cameron LNG's application to export 1.4 bcf/day of LNG to Non-Free Trade Agreement Countries that will be produced from two additional liquefaction trains proposed to be added at the Cameron LNG facility currently under construction in Cameron Parish, Louisiana, located in my congressional district.

Construction on the first three liquefaction trains at Cameron LNG, which was reviewed and approved by the Department of Energy and Federal Energy Regulatory Commission in 2014, has already provided a huge boost to the Southwest Louisiana regional economy and is expected to create an estimated 3,000 jobs at peak. This \$10 billion investment in our community has the strong support of local residents and businesses.

The proposed Cameron LNG expansion project would generate even more benefits to the community. The two new liquefaction trains would keep thousands of workers employed at the site for a longer period of time during the construction phase, while increasing the number of permanent jobs from 140 to 190. Also, the additional volume of LNG exported from Cameron LNG would further improve U.S. balance of trade by \$114 billion.

Southwest Louisiana is leading the way to help U.S. rapidly become a major supplier of LNG to markets around the world with projects like Cameron LNG. By taking advantage of our vast natural gas resources and world-class infrastructure, we can continue creating jobs and economic opportunity for years to come. I respectfully request every proper consideration be provided to Cameron LNG's application.
