Re: Louisiana LNG Energy, LLC, FE Docket No. 14-019-LNG and FE Docket No. 14-029-LNG, Notice of Change in Control

Dear Mr. Anderson:

On May 21, 2015, Louisiana LNG Energy, LLC (“LLNG”) filed a Notice of Change in Control (i) amending the free trade agreement (“FTA”) export authorization issued in FE Docket No. 14-019-LNG and (ii) requesting approval of an amendment to the pending non-FTA export application in FE Docket No. 14-029-LNG. The purpose of the Notice of Change in Control was to reflect the acquisition of LLNG by Parallax Enterprises (NOLA) LLC (“Parallax NOLA”). On June 8, 2015, the Department of Energy Office of Fossil Energy (“DOE/FE”) issued a notice stating that LLNG had requested approval to change the applicant in the non-FTA proceeding from LLNG to Parallax NOLA. DOE/FE granted the request.

LLNG did not intend through its Notice of Change in Control to change the identity of the holder of the FTA authorization or the applicant in the non-FTA proceeding. While Parallax NOLA has acquired all of the outstanding membership interests in LLNG, LLNG will remain the holder of the FTA authorization and the applicant in the non-FTA proceeding. The Notice of Change in Control was intended to inform DOE/FE only of a change in LLNG’s upstream ownership. LLNG respectfully requests that LLNG be reinstated as the holder of the FTA authorization and as the applicant in the non-FTA proceeding. LLNG regrets any confusion that the Notice of Change in Control may have caused.
